#### Abstrak

The word reading has a number of common interpretations. It may mean reading aloud, a very complex skill, which involve understanding the black marks first and then the production of the right noises. Reading is a complex skill, that is to say that it involves a whole series lesson skill and also reading is a way of getting knowledge and one of literacy skills that enable students what they are learning, to help students aet а better understanding.

Reading Comprehension is one of the compulsory subjects should be taken by students who learn language. The materials as a whole are about basic skills in reading comprehension, finding topic sentence, practices on scanning and skimming. Kabilan, Seng and Kee(2010, p.128) reading is a dynamic, cognitive and interactive process and not merely a process of decoding of codes in printed form but a process of creating meaning as result of the transaction between the reader and the text".

Nowadays, due to the advantages technology, students can get suitable reading materials they need to support their comprehension. Obviously, the more scholarly the newspaper , the more important it is to them to maintain a good reputation for correct grammar, spelling, and other signs of good writing. Most newspaper are more interested in how many issues they can sell, rather than in facts. Also, since they are on a very short time schedule, they tend to have more typographic errors than books, which are typically edited 3 to 5 times before they are printed for



sale. Having said all that , reading almost anything in a foreign language will improve both reading and writing skills.

Based on the explanation above, the researcher thinks that teachers or lecturers should provide a media such article from magazines, newspaper, text book .novel to teach reading comprehension. #### Concept of Reading

Reading is the complex cognitive process of decoding symbols to derive meaning. It is a form of language processing and reading is a means for language acquisition, communication, and sharing information and ideas. Reading is the act of linking one idea to another. It is the activity to read, that has a purpose to get when information we learn English as a foreign language. It is an important thing for the teacher to mastering reading at understanding or constructing meaning from the written text. Reading is the process of putting the reader in the contact communicating with idea( Hornby, A,S, 1998).

Charles in Hamka (2005;9) stated that reading is a transmitting of information process where the author is regarded as the informant and the reader. According to Mark A. Clark and Sandra in Hamka (1988;15) define that reading is an active cognitive process of interacting with print and monitoring comprehension to establish meaning.

## Kinds of Reading Skills

Nasr (1984) divided reading into two kinds. Namely: silent reading and oral reading.

a. Silent reading

The main aim in silent reading is understand. We can do silent reading faster than oral reading because silent reading there is no oral expression.

b.Oral reading

Someone has firstly aood pronunciation to do oral reading well. In oral reading the students not only read orally. The passenger are given in oral reading .the students will get experience in producing to with could be practiced as many time as possible.

c. Comprehension

Comprehension is always directed and controlled by the needs and purpose of the reader, there for the reader can not read with good comprehension. If the subject of the text is one who does not know and has no real interest in it.

# Media

Bretzin in Suwarna divided media in 7 division, they are(1) moving audio visual media, (2) silent media, (3) moving visual media, (4) silence visual media, (5) semi moving media,(6) audio media and (7)printing media. Printing media include



newspaper, magazine ( house magazine, periodical magazine or newsletters), Tabloid , Booklet, Brochure, handbill, and press release.

#### What is The Procedure to Teach Read and Record Using on-line " The Jakarta Post News Report"

To used on-line media" News report" to teach English for the students of Government Program there are several steps that must followed by the students. The lecture give the task to find the sources from Academia opinion. The title contain about the government issue both local or foreign issue. Every meeting the students will find different title. Each of the students should get or find different article. There are 7 days in a week it is means that the students must share in the group WhatsApp their own title to make sure they don't have the same title. They must have different title. The same title will be rejected. Assigning all of the students to make the summary (written) of their title in their own language. They should try to find the difficult vocabularies and list in include all of the meaning. The students present the summary in their personal presentation by read and report the contain of the article. To make focus the audience, the presenter provide the material by sharing in WhatsApp group at the same time he/she present. To be able to present the article the students should comprehend or to get the meaning from the article.

It is common place in theories of reading as well as in everyday talk about reading to distinguish different levels of understanding of a text. Thus some may distinguish between а literal understanding of text. Thus, some may distinguish between a literal understanding of text, an understanding of meaning that are not directly stated in text, or an understanding of the main implications of text. According to Gray's (1960) distinction between ' the lines', reading reading between the lines and reading 'beyond the lines'. The first refers to the literal meaning of text, the second to inferred meanings, and the third to readers' critical evaluations of text. When we are reading ,we are clearly engaged in a great deal of mental activity, some of it automatic, some of it conscious.

To make other students be active, the lecturer give the role they must ask to the presenter about the article. Give the asking, additional, correction(may miss spell or mispronunciation explanation and etc. The student present the conclusion of the article and show the difficult or latest government vocabularies.

During the process of presentation the lecturer make notes about the mistakes of conclude the article, pronunciations, diction, grammar and etc. After no more questions or suggestion from the audience the lecturer make conclusion. Finally the students must submit



the report from the article to the lecturer. And the lecturer give comment or note on the report paper. Every meeting consist 20 students can present the article. These procedures are repeated for each meeting until the semester the ends. At the end of this procedure can be hoped to make the students familiar with article the that contain government issue and have many vocabularies so that they are mastering in reading and vocabulary government articles.

The New York City Board of Education is citied by Lunzer and Gardner (1979) as identifying thirty – six different skills. David (1968) defines eight skills, as follows:

- 1. recalling word meaning
- 2. drawing inferences about the meaning of a word in context
- 3. finding answers to questions answered explicitly or in paraphrase
- 4. weaving together ideas in the content
- 5. drawing inferences from the content
- 6. recognizing a writer's purpose, attitude,, tone and mood
- 7. identifying a writer's technique
- 8. following the structure of a passage

Reading efficient is an process because of the various processing skills that work smoothly together and also because of the reading rate which is approximately that people read about 250-300words per minute.

Carve(1982), shows that there are optimal rates of processing prose, and they are roughly equivalent for reading and listening, at 250 to 300 words per minute. And reading is an interactive process since the text provides information that the writer wants the reader to know and the reader in the process of constructing meaning related the text to their prior knowledge. Additionally, since the selection of material necessarily takes place before classroom use, typically it concern is with what Breen and Candlin (1987) and Breen(1989) describe as 'tasks as workplants'.

#### Reading skills and abilities

Reading means a set of skills that involves making sense and deriving meaning from the printed word (Linse, 2006, p.69). According to Brown (2004, p.186), there are three types (genres) of reading:

- 1) Academic reading; General interest articles (in magazines , newspapers , ect.),technical reports (e.g., lab reports ), professional journal articles, reference material (dictionaries, etc.), textbooks, ,essays, papers, test directions, editorials and opinion writing;
- 2) Job-related reading, such as messages, (e.g., phone letters/emails. messages), memos (e.g., interoffice), reports (e.g., job evaluations, project reports ), schedules, labels. signs, forms, announcements, application, questionnaires,



financial documents (bills, invoices, etc.), directories (telephone, office, etc.),manuals and directions;

reading; 3) Personal for examples: Newspapers, magazines. letters, emails, greeting cards, invitations, messages notes. lists. schedules (train, bus, plane, etc.), recipes, menus, maps, calendars. advertisements (commercials, want ads ), novels, short stories, jokes, poetry, financial drama documents (e.g., checks, tax forms. loan applications), questionnaires, forms, medical report, immigration documents. comic strips. cartoons.

Yang (1992) states that many school activities can be recorded (videotaped). Students performance in English can also be video typed . Furthermore he states that students may use camera for recording their rehearsal. They can record the text which read by their friends. Readers not only have knowledge to mastering the text but they have the ability to understand the text Thev prepare the material and choose the best topic to be recorded.

Use of the mass on-line media as a instrument in the classroom has increased considerably at all grade levels in the past few years. Part of on-line media Jakarta post that can be the materials to teach are :news, weather,entertainment,editorial,cl assified,sport,people,features,pict ures of articles and advertisement. By assess from the written News Report Article that their present in front of the class. 3. From final exam by asking the students to answer W-H questions and Yes or No Question base on their News report article vocabulary subject. Learner who have control of the high frequency words and who are studying for academic purposes.

The level of vocabulary: High frequency words, academic vocabulary, low frequency words and proper nouns. Vocabulary learning is greatly helped when listening if the teacher quickly defines unfamiliar words (Elley, 1989).
